#### For Non-EU citizens

#### **EU Blue Card**

A special residence and work permit for highly-skilled non-EU citizens (and their families). The EU Blue Card:

- Allows to start working right after the application is submitted;
- Can be applied for online;
- Provides a right to bring family members;
- Paves the way for permanent residence status after 5 years.

Danske's operation in Vilnius developed Danske MobilePay, an app that is installed on 90% of Danish smartphones, and is the leading mobile payment solution in the Nordics



The plant is the largest PET resin production single line plant in Europe with the lowest carbon footprint. Lithuania was chosen as home to this project because of its educated workforce, low energy costs and easy logistics due to its year-round ice-free port.





Lithuania is the company's main mobile technology engineering hub, where their first product for the iPhone, followed by the Unity Editor for Windows and Unity for Android were developed







Lithuania was chosen as home to this project because of its educated workforce, low energy costs and easy logistics due to its year-round ice-free port.

Indorama Ventures is now Thailand's largest investor in the Baltic States. Orion Global Pet gives priority to work safety, environmental protection and clients' needs. The company has installed 6 ISO standards. Orion Global Pet facility has received various awards for its activity and production here in Lithuania.






